### New Requirements, Tougher Penalties

- The Census Bureau now requires mandatory filing of export information through the Automated Export System (AES) or through the AES*Direct* for all shipments where a Shipper's Export Declaration was previously required.
- Penalties may be imposed per violation of the FTR from \$1,100 to \$10,000 – both civil and criminal – for the delayed filing, failure to file, false filing of export information, and/or using the AES to further any illegal activity.
