### **About the Survey**

- Part of the Economic Census taken every 5 years for years ending in "2" and "7"
- The only comprehensive, regularly collected data for businesses and business owners by
  - Minority status
    - Race
    - Ethnicity (Hispanic origin of any race)
  - Gender
  - Veteran status



## **Business Ownership by Race**

 Categories of ownership are based on the race of the person or persons who owned 51% or more of the stock or equity in the business in 2007.

 "Asian-Owned" is defined as any firm with Asian owners holding a 51% or larger stake in the business.



# **Business Ownership by Detailed Group**

Asian-owned businesses are further classified into the following detailed groups:

- Asian Indian-owned
- Chinese-owned
- Filipino-owned
- Japanese-owned
- Korean-owned
- Vietnamese-owned
- Other Asian-owned [for example, Hmong, Laotian, Thai, Pakistani, or Cambodian




# Asian-Owned Firms Outpace Growth of Non-Minority-Owned Firms



#### The Big Picture

- The Asian business community continues to grow in number and size at a fast rate.
- The fast growing trend of Asian-owned businesses continued into the most recent five-year period outpacing once again the growth of non-minority-owned firms in gross receipts (55 percent Asian growth), employment (28%) and number of firms (40%) between 2002 and 2007.
- Asian-owned businesses are also an engine of job creation, with paid employment growing by 28 percent from over 2.2 million workers to more than 2.8 million workers, compared to less than a 1% growth for non-minority-owned firms.
- Average employment per firm with employees was about 7 employees per Asianowned business with employees in 2007.
- The Asian-owned firms paid good wages to their employees. Average payroll per employee increased by 12 percent from about \$25,000 in payroll per employee in 2002 to \$28,000 in payroll per employee in 2007. The average payroll per employee for all minority-owned firms was about \$28,000 in 2007 and \$35,000 for non-minority firms.
- The faster growing Asian population increased by 16% during this period, compared to only 1% growth for non-minorities.

# Asian-Owned Firms with \$1 Million Plus in Sales




■ Asian Firms (\$1 million and above)

# Upside of \$1 Million Plus Firms

- While smaller in number, Asian-owned businesses with receipts of \$1 million or more generated a much larger percentage of all Asian business' revenues and paid employment than firms with receipts under \$1 million.
- Asian-owned firms with receipts of \$1 million or more represented 5 percent of all Asian firms but generated 72 percent of all Asian firms' gross receipts and 58 percent of all their paid employment.
- There were 78,144 Asian firms with gross receipts of \$1 million or more in 2007. These firms generated combined gross receipts of more than \$367 billion and employed over 1.6 million workers.
- Average gross receipts of Asian firms generating sales of \$1 million or more grew by 6 percent from \$4.5 million per firm in 2002 to \$4.7 million in 2007.
- Asian-owned firms in this size category also represented 55 percent of all minority-owned businesses generating \$1 million or more in receipts in 2007.

# Entrepreneurial Parity

- At MBDA, we measure entrepreneurial parity of minority-owned firms.
- Asians-owned firms are the first minority group to reach entrepreneurial parity in number of firms and employment by reaching the same proportionality in these business measures as their share of the adult Asian population which was 4.9 percent.
- Asian-owned firms surpassed their parity levels in number of firms and employment but closely trailed in gross receipts.
- If Asian-owned firms would have reached parity in gross receipts with their share of the adult Asian population in 2007, these firms would have generated \$538 billion instead of \$508 billion – a gap of about \$30.1 billion.
- However, when we analyzed the data by ethnic group, Filipino-, Vietnamese, and Japanese-owned businesses have yet to reach entrepreneurial parity in all three business measures with their share of their adult population.

#### Room to Grow



- Although average gross receipts for Asian-owned firms increased by 11 percent from \$296,002 in 2002 to \$327,582 in 2007, this is still well below that of nonminority-owned firms (\$490,000).
- Asian-owned firms with employees represented 26 percent of all Asian-owned firms. This is a relatively large share. However their employment averaged to 7 employees per firm with employee, compared to an average of 12 employees for non-minority-owned firms with employees.
- There are about 1.5 million businesses owned by Asian Americans across America. MBDA's goal is to help grow those in emerging industries and with the potential for size and scale, as well as encourage job creation among these firms.
- As the Asian population increases in the U.S., the success of the Asian community becomes critical for job creation.

#### The Future

- MBDA is committed to making sure the growth and competitiveness of the minority business community continues to be a national priority.
- MBDA is creating the foundation for the next generation of \$100 million minority-owned firms capable of employing the growing minority and U.S. population, expanding the national tax base, and securing our position as a global leader.
- In fiscal year 2010, MBDA assisted minority owned firms in accessing more than \$3.9 billion in contracts and financings, and creating about 6,400 jobs.
- To grow more minority-owned firms in size and capacity, MBDA encourages minority businesses to consider growth by mergers and acquisition, joint ventures and strategic partnerships.



  - o 37.0% in California

  - San Francisco-Oakland-Fremont MSA: Asian owned firms grew by 31% between 2002 & 2007
  - San Jose-Sunnyvale-Santa Clara MSA: Asian owned firms grew by 48% between 2002 & 2007
- Effects of the recession on the business climate for Asian American entrepreneurs around the following issues
  - Access to Capital
  - Contract Procurement
  - Access to New Markets
