


# **MONTHLY CONSTRUCTION SPENDING, FEBRUARY 2018**

Release Number: CB18-49

**April 2, 2018** — The U.S. Census Bureau announced the following value put in place construction statistics for February 2018:





#### **Total Construction**

Construction spending during February 2018 was estimated at a seasonally adjusted annual rate of \$1,273.1 billion, 0.1 percent ( $\pm 1.2$  percent)\* above the revised January estimate of \$1,272.2 billion. The February figure is 3.0 percent ( $\pm 1.5$  percent) above the February 2017 estimate of \$1,235.7 billion. During the first two months of this year, construction spending amounted to \$176.3 billion, 4.4 percent ( $\pm 1.3$  percent) above the \$168.9 billion for the same period in 2017.

# **Private Construction**

Spending on private construction was at a seasonally adjusted annual rate of \$982.0 billion, 0.7 percent (±1.6 percent)\* above the revised January estimate of \$974.8 billion. Residential construction was at a seasonally adjusted annual rate of \$533.4 billion in February, 0.1 percent (±1.3 percent)\* above the revised January estimate of \$532.9 billion. Nonresidential construction was at a seasonally adjusted annual rate of \$448.6 billion in February, 1.5 percent (±1.6 percent)\* above the revised January estimate of \$441.9 billion.

### **Public Construction**

In February, the estimated seasonally adjusted annual rate of public construction spending was \$291.1 billion, 2.1 percent (±1.6 percent) below the revised January estimate of \$297.4 billion. Educational construction was at a seasonally adjusted annual rate of \$74.6 billion, 0.5 percent (±2.6 percent)\* below the revised January estimate of \$75.0 billion. Highway construction was at a seasonally adjusted annual rate of \$88.5 billion, 0.2 percent (±5.4 percent)\* below the revised January estimate of \$88.7 billion.

#### **Notice**

With the May 2018 release, unadjusted data will be revised back to January 2016 and seasonally adjusted data will be revised back to January 2011. With each May release, seasonally adjusted data will now be revised for an additional five years beyond the revision period for unadjusted data. Research has shown that this revision span should produce more reliable seasonally adjusted time series.

# **EXPLANATORY NOTES**

In interpreting changes in the statistics in this release, note that month-to-month changes in seasonally adjusted statistics often show movements which may be irregular. It may take 2 months to establish an underlying trend for total construction and as long as 8 months for specific categories of construction. The statistics in this release are estimated from several sources and surveys and are subject to sampling variability as well as nonsampling error including bias and variance from response, nonreporting, and undercoverage. Estimates of the standard errors are provided in Table 3. Whenever a statement such as "2.3  $(\pm 3.1)$  percent above" appears in the text, this indicates the range (-0.8 to +5.4 percent) in which the actual percentage change is likely to have occurred. All ranges given are 90 percent confidence intervals and account only for sampling variability. If a range does not contain zero, the change is statistically significant. If it does contain zero, the change is not statistically significant; that is, it is uncertain whether there was an increase or decrease. Statistics for the current month are preliminary estimates subject to revision in following months as additional data become available. The average absolute percent changes from preliminary estimate to first revision for the major seasonally adjusted components are as follows: total construction, 0.79 percent; private construction, 0.75 percent; and public construction, 1.73 percent.
