

# Market Absorption of Apartments

Privately financed apartments completed during the July-September 1979 quarter were 81 percent abosrbed (seasonally adjusted) 3 months after their completion. This is about the same, as the seasonally adjusted rate of 80 percent for apartments completed during the second quarter of 1979. The nonseasonally adjusted rate of 83 percent does not differ significantly from the seasonally adjusted rate. Apartments which have been on the market for 9 months—those completed during January-March 1979—were 99 percent absorbed (see table 3).

The median asking rent for newly constructed units was \$285. Apartments renting for less than \$200 accounted for 5 percent of the total, while those renting for \$200 to \$249 accounted for 24 percent. In comparison, 30 percent rented for \$250 to \$299 and 41 percent rented for \$300 or more (see table 1).

The data are based on a sample survey and consequently the figures cited above are subject to sampling variability. As shown in table 3, the 81 and 99 percent figures are subject to sampling errors (i.e., standard errors) of 1.9 and 0.5 percentage points, respectively. This means that there are about 2 chances

out of three that a complete count would be in the range of 81 ( $\pm$  1.9) percentage points and 99 ( $\pm$  0.5) percentage points. Sampling errors for the figures that follow are indicated in parenthesis.<sup>1</sup>

A total of 123,400 ( $\pm$  4,630) apartments were completed during the third quarter of 1979. Of the total, some 67,700 ( $\pm$  2,430) or 55 percent ( $\pm$  1.8) were the type covered by the Survey of Market Absorption (SOMA), i.e., privately financed, unfurnished rental units built without Federal subsidary in buildings with five or more apartments.

Of the remaining 45 percent ( $\pm$  1.8), cooperatives and condominiums account for 20 percent ( $\pm$  1.4) of the total with a 3-month absorption rate of 76 percent ( $\pm$  3.4)—(see table 4). Furnished rental units account for 3 percent ( $\pm$  0.6). Also excluded from the survey are units in federally subsidized properties built under these programs of the Department of Housing and Urban Development: Senior Citizens Housing direct loans (Section 202), FHA below market interest rate



mortgages (Section 236), and all units in buildings containing apartments in the FHA rent supplement program, which together account for 20 percent ( $\pm$  1.4). The remainder are excluded for other reasons, such as turnkey housing (privately built and sold to local public housing authorities subsequent to completion). The data, however, include privately owned housing subsidized by State and local governments.

# SAMPLE DESIGN

The Survey of Market Absorption (SOMA) is designed to provide data concerning the rate at which nonsubsidized and unfurnished privately financed units in buildings with five or more units are rented (or absorbed). In addition, data on characteristics of the units, such as rent and number of bedrooms, are collected.

The buildings selected for SOMA are those included in the Census Bureau's Survey of Construction (SOC)<sup>2</sup>. For this survey, the United States is first divided into primary sampling

units (PSU's) which are sampled on the basis of population. Next, a sample of permit-issuing places is selected within each sample PSU. Finally, all buildings within sampled places with five or more units as well as a subsample of buildings with one to four units are selected.

Each quarter, all buildings with five or more housing units in the SOC sample reported as completed during that quarter come into sample for SOMA. Buildings completed in nonpermitissuing areas are excluded from consideration. Information on the proportion of units absorbed 3, 6, 9, and 12 months after completion is obtained for units in buildings selected in a given quarter in each of the next four quarters.

Each quarter the absorption data for some buildings are received too late for inclusion in the report. These late data will be included in a revised table in the next quarterly report. (See table 2.)

### **ESTIMATION**

Unbiased quarterly estimates are formed by multiplying the counts for each building by its base weight (the inverse of its probability of selection) and then summing over all buildings.

The final estimate is then obtained by multiplying the unbiased estimate by the following ratio estimate factor:

total units in 5 + buildings in permit-issuing areas as estimated by the SOC for that quarter

total units in 5 + buildings as estimated by SOMA for that quarter

When all the completed 5+ buildings in the SOC are designated for SOMA, as is currently the case, this ratio estimate factor will be close to one. This procedure produces estimates of the units completed in a given quarter which are consistent with the published figures from the Housing Completions Series,<sup>3</sup> and also reduces, to some extent, the sampling variability of the estimates of totals.

It is assumed that the absorption rates and other characteristics of units not included in the interviewed group or not accounted for are identical to rates for units where data were obtained. The noninterviewed and not accounted for cases comprise less than 2 percent of the sample housing units in this survey.

### RELIABILITIES OF THE ESTIMATES

There are two types of possible errors associated with data from sample surveys: sampling and nonsampling errors. The following is a description of the sampling and nonsampling errors associated with SOMA.

### Nonsampling Errors

In general, nonsampling errors can be attributed to many sources: inability to obtain information about all cases, definitional difficulties, differences in the interpretation of questions, inability or unwillingness to provide correct information on the part of respondents, mistakes in recording or coding the data, and other errors of collection, response, processing, coverage, and estimation for missing data.

## Sampling Errors

The particular sample used for this survey is one of a large number of possible samples of the same size that could have been selected using the same sample design. Even if the same questionnaires, instructions, and interviewers were used, estimates from each of the different samples would differ from each other. The deviation of a sample estimate from the average of all possible samples is defined as the sampling error. The standard error of a survey estimate attemps to provide a measure of this variation among the estimates from the possible samples and, thus, is a measure of the precision with which an estimate from a sample approximates the average result of all possible samples.

As calculated for this survey, the standard error also partially measures the variation in the estimates due to response and interviewer errors (nonsampling errors), but it does not measure, as such, any systematic biases in the data. Therefore, the accuracy of the estimates depends on both the sampling and nonsampling error measured by the standard error, biases, and some additional nonsampling errors not measured by the standard error.

The sample estimate and its estimated standard error enable the user to construct confidence intervals, ranges that would include the average result of all possible samples with a known probability. For example, if all possible samples were selected, each of these were surveyed under essentially the same general conditions, and an estimate and its estimated standard error were calculated from each sample, then:

- Approximately 68 percent of the intervals from one standard error below the estimate to one standard error above the estimate would include the average result of all possible samples.
- Approximately 90 percent of the intervals from 1.6 standard errors below the estimate to 1.6 standard errors above the estimate would include the average result of all possible samples.
- Approximately 95 percent of the intervals from two standards errors below the estimate to two standard errors above the estimate would include the average result of all possible samples.

For very small estimates, the lower limit of the confidence interval may be negative. In this case, a better approximation to the true interval estimate can be achieved by restricting the interval estimate to positive values, that is, by changing the lower limit of the interval estimate to zero.

The average result of all possible samples either is or is not contained in any particular computed interval. However, for a particular sample, one can say with specified confidence that the average result of all possible samples is included in the constructed interval.

The conclusions stated in this report are considered significant at the 95 percent confidence level.

For example, table 1 of this report shows that there were 32,800 apartments with two bedrooms in the third quarter of 1979. The standard error of this estimate is 2,040. The 68 percent confidence interval as shown by these data is from 30,760 to 34,840. Therefore, a conclusion that the average estimate derived from all possible samples lies within a range computed in this way would be correct for roughly 68 percent of all possible samples. Similarly, we could conclude that the average estimate derived from all possible samples lies within the interval from 28,720 to 36,880 (using twice the standard error) with 95 percent confidence.

The data in this report are preliminary and subject to slight changes in the annual report.
