


# PROPERTY AND INDIVIDUAL INCOME TAXES REVENUES SHOW SIGNIFICANT INCREASES

#### **2017 QUARTER 4**

Fourth quarter 2017 tax revenues for the four largest state and local government tax categories increased 9.5 percent to \$438.8 billion, from \$400.8 billion in the same quarter of 2016.<sup>2</sup>

# State and local governments collect \$226.8 billion in property tax revenue

The estimated total for fourth quarter 2017 state and local property tax revenue increased 9.1 percent to \$226.8 billion ( $\pm$ 7.0 billion), from \$207.9 billion ( $\pm$ 6.6 billion) collected in the same quarter of 2016. Local governments collected \$222.2 billion of total property tax revenue in the fourth quarter of 2017.

#### Individual income tax collections grow

Individual income tax collections in the fourth quarter of 2017 shows an increase of 13.7 percent to \$101.6 billion (±0.4 billion), from \$89.4 billion (±0.3 billion) in the same quarter of 2016.

### General sales and gross receipts tax revenue increases

General sales and gross receipts tax revenue was \$99.0 billion (±0.6 billion) in the fourth quarter of 2017, up 6.7 percent from the \$92.8 billion (±0.6 billion) collected in the same quarter of 2016.

#### Corporation net income tax revenue rises

Corporation net income tax revenue for the fourth quarter of 2017 increased 7.1 percent to \$11.5 billion (±0.05 billion), from \$10.7 billion (±0.1 billion) in the same quarter of 2016.

# STATE TAX COLLECTIONS CONTINUE TO INCREASE


Total state tax revenue increased 9.5 percent to \$242.8 billion in the fourth quarter of 2017, from \$221.7 billion reported in the same quarter of the prior year. Individual income tax, at \$92.5 billion, is up 14.4 percent from \$80.9 billion in the same quarter of 2016. The second largest category of

state tax revenue is general sales and gross receipts taxes, which accounted for \$77.4 billion, an increase of 6.4 percent from \$72.7 billion the same quarter in 2016. At \$9.5 billion, corporation net income tax collections are up from \$8.7 billion the same quarter in 2016, an increase of 8.8 percent.

The majority of the nation's state tax revenue came from individual income (38.1 percent) and general sales and gross receipts (31.9 percent). Figure 4 illustrates the fourth quarter percentage distribution of state government revenues by tax type for the nation and the four census regions. In the Northeast, West, and Midwest regions, individual income tax collections accounted for the largest percentage of tax collections with 49.3 percent, 43.3 percent, and 36.7 percent, respectively. In the South, general sales and gross receipts taxes were the largest of the four main categories at 40.5 percent.


