STATE AND LOCAL GOVERNMENT TAX REVENUE²

Second quarter 2019 combined tax revenues for property, sales and gross receipts, and income taxes increased 9.0 percent to \$398.7 billion from \$365.7 billion in the same quarter of 2018.³

Property tax revenue


The estimated total for the second quarter of 2019 state and local property tax revenue was \$153.2 billion (±3.4 billion), an increase of 8.2 percent from \$141.7 billion (±3.2 billion) collected in the same quarter of 2018.

Individual income tax collections


Individual income tax collections in the second quarter of 2019 shows an increase of 16.8 percent to \$121.7 billion (±0.8 billion), from \$104.1 billion (±0.4 billion) collected in the same quarter of 2018.

General sales and gross receipts tax revenue

General sales and gross receipts tax revenue was \$106.2 billion (±0.8 billion) in the second quarter of 2019, an increase of 1.4 percent compared to \$104.7 billion (±0.6 billion) collected in the same quarter of 2018.

Corporation net income tax revenue

Corporation net income tax revenue for the second quarter of 2019 was \$17.6 billion (±0.3 billion), an increase of 15.6 percent from the \$15.3 billion (±0.1 billion) collected in the same quarter of 2018.

STATE TAX COLLECTIONS⁴

Total state tax revenue increased 8.3 percent to \$331.6 billion in the second quarter of 2019, from \$306.1 billion reported in the same quarter of 2018. Individual income tax, at \$140.6 billion, is up 17.8 percent from \$119.4 billion in the same quarter of 2018. General sales and gross receipts taxes, which accounted for \$91.5 billion, increased 0.3 percent from \$91.2 billion in the same quarter of 2018. At \$25.9 billion, corporation net income tax



Distribution of State Government Revenue by Type of Tax for the Nation and Census Regions: 2019 Q2 (In percent)




collections increased 18.4 percent from the \$21.8 billion collected in the same quarter in 2018.

The majority of the nation's state tax revenue came from individual income (42.4 percent), and general sales and gross receipts (27.6 percent). In the Northeast, West, and Midwest regions, individual income tax collections accounted for the largest percentage of tax collections with 51.8 percent, 49.3 percent, and 42.8 percent, respectively. In the South, general sales and gross receipts taxes were the largest of the four main categories at 39.9 percent.
