The Complexity of Men's Fathering

- About 62% of men (~75 million) are fathers to biological, step, or adopted children
- About 15% of men have biological children with more than one woman
- Among fathers of minor (<18) biological children, about 25% do not live with all of their minor biological children
- About 9% of men are living with children <18 who are not "theirs"

About the Survey of Income & Program Participation (SIPP)

- The SIPP is a nationally representative survey of the civilian noninstitutionalized population.
- The data used here come from Wave 1 of the 2014 SIPP.
 - The Census Bureau has been administering the SIPP since the 1980s, but the instrument was overhauled for the 2014 panel
 - The 2014 SIPP is the first Census Bureau survey to collect a complete fertility history for both women and men.
 - The SIPP also includes detailed relationship information for all household members.




Fathering within the household




About 36 million men live with about 70 million minor children (<18)


CORESIDENT CHILDREN: The children with whom a man lives vary by age within relationship type




Fathering outside the household





About 7.7 million fathers (11.8%) report that they have a child <21 who lives elsewhere with their other parent.

SUMMARY

- Men's family situations are diverse, including a variety of children and family types, and often extending beyond a single household
- Men's contact and coresidence with those children varies by both the children's demographics and the men's demographics

NEXT STEPS

- Refine the existing analysis additional measures, more nuanced controls
- Look at the same measures from the perspective of children
