







# **New Report Overview**


- \$2.8 trillion in federal funding distributed in fiscal year 2021 guided by Census Bureau data in whole or in part.
- Previous estimate released in 2017 was \$675+ billion.
- Report methodology.
- People's responses matter.




# **CENSUS DATA AND FEDERAL FUNDS DISTRIBUTION**



### **PREVIOUS RESEARCH**

- Census Bureau data touches hundreds of federal programs.
  - Authored 2019 report identifying \$1.5 trillion in census-guided federal spending for FY17.
  - Census-derived data also guide the day-to-day economic activity across the U.S.





### **NEW RESEARCH**

The new estimate for FY21 makes clear the substantial importance of census data in evidence-based policymaking and in making more possible a healthy economy shared by all Americans.

# USES OF DECENNIAL CENSUS PROGRAMS DATA IN FEDERAL FUNDS DISTRIBUTION: FISCAL YEAR 2021

# THE FINDINGS

- Inventory of programs
  - At least 353 federal assistance programs used Decennial Census Programs data to distribute federal funds in FY2021
- Estimate of federal funds distribution
  - More than \$2.8 trillion in federal funds were distributed using Decennial Census Programs data in whole or in part in FY2021
  - Largest federal funding programs account for about 90 percent of total federal funds distributed in FY2021

# Uses of Decennial Census Programs Data in Federal Funds Distribution: Fiscal Year 2021

# **BACKGROUND**


- Illustrating the value of accurate Census Bureau data increases the likelihood of participation in a census or survey.
- As the Census Bureau was actively preparing for the 2020 Census, the Census Bureau released a working paper that found "more than 675 billion" of federal funds were distributed using Decennial Census Programs data in fiscal year 2015.
- Amount of federal funds distributed using Decennial Census Programs data in whole or in part is frequently used to illustrate the value of accurate data to encourage participation in our censuses and surveys.
- Important to note: The Census Bureau does not distribute or determine federal funding for any program, nor does the Census Bureau determine how the data are used by federal programs or in funding formulas.

### THE ANALYSIS

Build on the previous work and, in partnership with the George Washington Institute of Public Policy at George Washington University and Dr. Andrew Reamer, document an estimate of the allocation of federal funds distributed using Decennial Census Programs data.

Federal financial assistance programs use Decennial Census Programs data in whole or in part to guide funds distribution in any of three ways:

- **Definition of eligible recipients.** Many programs use data derived from Decennial Census Programs to define the characteristics of geographic areas, state and local governments, and populations eligible to receive funds.
- Variables in funds allocation formulas. Many programs use data derived from Decennial Census Programs as variables in the formulas used to determine the allocation of funds to eligible recipients.
- Applicant selection criteria. Several competitive financial assistance programs use data derived from Decennial Census Programs to specify criteria by which the sponsoring agency will rank and select award recipients.









# THE METHODOLOGY

- Update the catalog of programs identified in 2017
  - Reviewed the existing inventory of programs from the Census Bureau's report released in 2017 and from "Counting for Dollars 2020: The Role of the Decennial Census in the Geographic Distribution of Federal Funds"
  - Conducted an examination of other programs identified by using machine learning techniques
  - Examined information on the programs to determine their use of Decennial Census Programs data in the System for Award Management (sam.gov)
- Update estimate of funds distributed
  - Use fiscal year 2021 funding from USAspending for programs in scope for this analysis
  - For a funding amount not available in USAspending.gov, alternative sources for the program were used



# EXAMPLES OF HOW PROGRAMS ARE USING DECENNIAL CENSUS PROGRAMS DATA

### **Per Capita Income for Medical Assistance Program**

The Secretary calculates the percentages, using formulas in sections 1905(b) and 1101(a)(8), and calculations by the Department of Commerce of average income per person in each state and for the Nation as a whole. The percentages must fall within the upper and lower limits specified in section 1905(b) of the Act. The percentages for the District of Columbia, Puerto Rico, the Virgin Islands, Guam, American Samoa, and the Northern Mariana Islands are specified in statute, and thus are not based on the statutory formula that determines the percentages for the 50 states.

### **Urbanized Areas for the Federal Transit Formula Grants**

The Urbanized Area Formula Funding Program (49 U.S.C. 5307) makes federal resources available to local and regional government authorities and states for transit capital and operating assistance and for transportation-related planning in urbanized areas. An urbanized area is an area encompassing a **population of not less than 50,000** that has been defined and designated in the most recent decennial census as an 'urbanized area' by the Secretary of Commerce, Bureau of the Census.

# Unemployment Statistics for the Coronavirus State and Local Recovery Funds and Homeowner Assistance Fund


"...in an amount which bears the same proportion to such remainder as the average estimated **number of seasonally-adjusted unemployed individuals**..."

"The statute requires the Department of the Treasury to make allocations for each state, the District of Columbia, and Puerto Rico based on homeowner need, determined by reference to (1) the average **number of unemployed individuals**..."



# **In Summary**

- **\$2.8 trillion** in federal funding distributed in fiscal year 2021 guided by Census Bureau data in whole or in part.
- At least 353 federal assistance programs used Decennial Census Programs data to distribute federal funds in FY2021.
- Largest federal funding programs
   account for about 90 percent of total
   federal funds distributed in FY2021.
- People's responses matter.


