# The U.S. Census Bureau's Puerto Rico Community Survey (PRCS)

The **Puerto Rico Community Survey (PRCS)** is part of the American Community Survey (ACS) that is customized for Puerto Rico. The PRCS provides data every year—giving communities in Puerto Rico the current information they need to manage change and plan for the future. Information from the ACS and PRCS generate data that help inform how trillions of dollars in federal funds are distributed every year.

The PRCS is unique in its ability to produce estimates for a wide range of topics for multiple geographies including the commonwealth, municipios, zonas urbanas, barrios, subbarrios, and smaller areas such as census tracts and block groups.

# What Topics Are Covered in the PRCS?

The PRCS covers a wide range of topics including social, economic, demographic, and housing characteristics. Policymakers, business leaders, planners, and others nationwide rely on these data to make informed decisions.

#### **How Often Are PRCS Data Released?**

PRCS data are timely because they are released immediately following the year in which they are collected. The data collected by the PRCS are used to create period estimates, which means they represent the characteristics of the population and housing over a period of time. The PRCS data are released as part of the ACS estimates for 1-year and 5-year periods.

# **How Are PRCS Data Collected?**

Households that receive the survey can respond by mail, phone, or a personal visit with a field representative. The Census Bureau selects a random sample of about 36,000 housing unit addresses to be included in the PRCS. Each address has about a 1-in-480 chance of being selected in a month, and no address is selected more than once every 5 years. People living in group quarters facilities such as college dormitories, nursing homes, and prisons are also sampled.
