### **1890 Census**

**Question:** Whether a soldier, sailor, or marine during the civil war (United States or Confederate), or widow of such person.

**Instructions:** Write "Sol" for soldier, "Sail" for sailor, and "Ma" for marine. If the person served in the United States forces add "U.S." in parentheses, and if in the Confederate forces add "Conf." in parentheses, thus: Sol (U.S.); Sail (U.S.); Sol (Conf.), etc. In the case of a widow of a deceased soldier, sailor, or marine, use the letter "W" in addition to the above designations, as W. Sol (U.S.), W. Sol (Conf.), and so on.

The enumeration of the survivors of the late war, including their names, organizations, length of service, and the widows of such as have died, is to be taken on a special schedule prepared for the purpose, as provided for by the act of March 1, 1889, and *relates only to those persons, or widows of persons, who served in the Army, Navy, or Marine Corps of the United States in the late war.* The inquiry concerning the survivors of both the United States and Confederate forces is made on the population schedule so as to ascertain the *number* now living and the *number* who have died and have left widows.

#### **1910 Census**

**Question:** Whether a survivor of the Union of Confederate Army or Navy

**Instruction:** This question should be asked as to all males over 50 years of age who were born in the United States and all foreign born males who immigrated to this country before 1865. Write "UA" if a survivor of the Union Army; "UN" if a survivor of the Union Navy; "CA" if a survivor of the Confederate Army; and "CN" if a survivor of the Confederate Navy. For all other persons leave the column blank.

## 1930 Census

**Question:** Whether the person is a veteran of the U.S. military or naval forces mobilized for any war or expedition? If yes, which war or expedition?

**Instructions:** Enumerators were to enter "WW" for World War I, "Sp" for the Spanish-American War, "Civ" for the Civil War, "Phil" for the Phillipine insurrection, "Box" for the Boxer rebellion, or "Mex" for the Mexican expedition.

### **1940 Census**

The 1940 census was the first to include a statistical sample. Five percent of people were asked an additional 16 questions. In order to gauge the effect of the Great Depression on the nation's housing stock, a census of occupied dwellings was coupled with the usual demographic questions.

**Long Form Question:** Is this person a veteran of the United States military forces; or the wife, widow, or under-18-year old child of a veteran? (If so enter "Yes")

- If the person is a child of a veteran, is the veteran father dead?
- War or military service

**Instructions:** Enumerators were to mark "W" for World War I; "S" for the Spanish-American War, the Phillipine insurrection, or Boxer Rebellion; "SW" for both the Spanish-American War and World War I; "R" for peacetime service only; or "Ot" for any other war or expedition.

### **1950 Census**

The 1950 census population questionnaire asked fewer questions than its predecessor; the full population was asked only 20 questions. As in 1940, a 5 percent sample was asked an additional slate of questions.

**Long Form Question (5% sample):** If male: did he ever serve in the U.S. Armed Forces during...

- a) World War II
- b) World War I
- c) Any other time, including present service

### 1960 Census

For the first time in 1960, the Census Bureau mailed out a combined population and housing questionnaire to all urban residents in the United States. Residents were to complete the questionnaire themselves and hold it until an enumerator came visit and collect the form. Enumerators then gave an additional sample questionnaire to 25 percent of households, with instructions to mail it back to their census office. Rural residents were enumerated by traditional visitation. The census "short form" collected only five questions: age, sex, race, and marital status.

**Long Form Question:** (asked of population 15 and older) If this is a man—Has he ever served in the Army, Navy, or other Armed Forces of the United States? (Yes, No) If so, was it during the:

- Korean War (June 1950 to Jan. 1955)
- World War II (Sept. 1940 to July 1947)
- World War I (April 1917 to Nov. 1918)

• Any other time, including present service

# **1970 Census**

The 1970 census was the first to operate on a true mail-out mail-back system. Because enumerators were only sent out to collect information from non-responding residents, the census questionnaire was designed to be filled out by the members of each household. The first eight questions were asked of every resident. All following questions, including the entire census of housing, were asked of a sample of either five, fifteen, or twenty percent of residents. The second question aims to get at whether the respondent was on active duty in the Armed Forces.

**Long Form Question:** (asked of population 15 and older) If the person is a man- has he ever served in the Army, Navy, or other Armed Forces of the United States? Was it during the...

- Vietnam Conflict (since Aug. 1964)
- Korean War (June 1950 to Jan 1955)
- World War II (Sept. 1940 to July 1947)
- World War I (April 1917 to Nov. 1918)
- Any other time

In April 1965 was this person...

- Working at a job or business (yes, no)
- In the Armed Forces (yes, no)
- Attending College (yes, no)

### **1980 Census**

**Long Form Question:** (asked of population 15 and older)

In April 1975 (five years ago) was this person-

- On active duty in the Armed Forces? (yes, no)
- Attending college? (yes, no)
- Working at a job or business? (yes, no) If yes, full time or part time?

Is this person a veteran of active-duty military service in the Armed Forces of the United States? Was active duty military service during-

- May 1975 or later
- Vietnam era (August 1964 April 1975)
- February 1955 July 1964
- Korean conflict (June 1950 January 1955)
- World War II (September 1940 July 1947)
- World War I (April 1917 November 1918)
- Any other time

# 1990 Census

The 1990 census asked only seven population and seven housing questions. A sample of respondents received the "long form," which included 23 more population inquiries.

**Long Form Question:** Has this person ever been in active-duty military service in the Armed Forces of the United States or ever been in the United States military Reserves or the National Guard? *If service was in Reserves or National Guard only, see instruction guide.*

### **2000 Census**

The 2000 census short form asked eight questions to all respondents. The long form, which combined housing and population questions into a single questionnaire, asked an additional 45 questions, all respondents were asked Questions 1 - 6 and Question 33.

**Long Form Questions:** Has this person ever served on active duty in the U.S. Armed Forces, military Reserves, or National Guard? *Active duty does not include training for the Reserves or National Guard, but DOES include activation, for example, for the Persian Gulf War.*

# The American Community Survey (ACS)

The nationwide American Community Survey (ACS) is a critical element of the Census Bureau's reengineered decennial census program. The more detailed socioeconomic information once collected via the long-form questionnaire of the decennial census is now collected by the American Community Survey. The survey provides current data about all communities every year, rather than once every 10 years. It is sent to a small percentage of the population on a rotating basis throughout the decade. No household will receive the survey more often than once every five years. In 1995, the U.S. Census Bureau began the process of changing the means of obtaining the demographic, housing, social, and economic information from the census long form to the ACS. Testing began in 1996, and the ACS program began producing test data in 2000, 2001, and 2002. The full implementation started in 2005, The first 5-year estimates, based on ACS data collected from 2005 through 2009, will be released in 2010.
