Two Innovations

- Question Template
 for the questionnaire design process
- MicroTesting
 to supplement the qualitative testing plan



Question Template: A Helpful Communication Tool for Team Questionnaire Design



Background

- Annual Social and Economic Supplement (ASEC) of the Current Population Survey (CPS) "modernization"
 - Introduce web-based instrument for self-administration
- Large redesign
 - 30+ SMEs, 4 years, multiple stages of qualitative testing
 - Conducting quantitative testing on Census panels
 - 1 methodologist
- SMEs were the authority on the redesign
 - First draft of new questions
 - Not methodologists



How to make this work?

Need to

- Understand the SMEs' goals for each question
- Provide feedback and encourage good questionnaire design
- Develop an effective protocol (probes) to get the info we need to make decisions
- Keep a record of changes/versions



Question Template

- 1. Research Question (Motivation)
- 2. Universe
- 3. Question Text (with response options, instructions, and fills)
- 4. Report back



Question Template Example

Research Question: Concerned that hours worked instruction is being ignored and people are reporting their "favorite" employer or the job they went to school for instead. Particularly worried about those working in the gig economy.

Universe: Q6 Working = Yes (1)

Q7: What is the name of your MAIN job?

If you have more than one job, answer for the job in which you work the most hours.

Name of MAIN job: _____

Report: Are respondents reading the instruction? Whether they read it or not, are they naming the job where they work the most hours?

Outcomes

- Met the goals outlined earlier (version control, develop protocols)
- Provided structure to a daunting task
- Facilitated communication
- Easy to understand and implement

Other Benefits

- Used as programming spec
- Templates defined the format of the contractor's report
- SMEs' basic questionnaire design skills improved



Conclusion: Question Template

Whether working with methodologists or non-methodologists, the template is beneficial for any team questionnaire design.

MicroTesting: Quick and Focused Qualitative Testing



Background

 ASEC redesign involves lengthy and extensive qualitative testing, done through a contract

ASEC Stages:

- Exploratory interviews
- Rounds 1 and 2 of Cognitive Interviewing
- Usability
- Field test
- Pressure to make significant progress at each stage
- Hard to introduce additional testing



How can we introduce some flexibility?

- Testing method that
 - Provides a nimble approach to address problems quickly, without having to wait for the next large round of testing
 - Takes the pressure off having to solve every problem within a couple rounds of cognitive testing
 - Allows for A/B testing when trying to decide between two questions
 - Gives the methodologist a tool to make a justified recommendation when literature isn't available



What is MicroTesting?

Mini qualitative test(s), usually cognitive interviewing

Each test:

- Small sample (6-10 people)
- Short instrument
- Focused
 - Specific problem
 - Targeted respondent attributes
- Test should take 10-20 minutes



More Detail about MicroTesting

- OMB approval secured as part of larger testing package
- All parts of the test conducted in-house
 - Designing protocol and respondent materials
 - Programming and testing web survey for respondent
 - Recruitment
 - Interviewing
- Can offer a small digital incentive



Variations on MicroTesting

- Methodology is adaptable, depending on the problem being addressed
 - Conduct one test for one section of the survey
 - Conduct several tests, each on different sections of the survey
 - Testing on a single section is iterative, processing results and then fielding again
- Timing is flexible: Done between other testing rounds or concurrently
 - Between rounds helps to refine before next large round of testing
 - Concurrent done for subgroups not targeted in large tests



Examples of MicroTesting

- 1. Exploratory interviews found that people don't understand "health insurance", "health plan", or "health coverage". Since a term must be chosen for cognitive testing and the decision impacts many questions in the health insurance instrument, MicroTesting can be done to focus on this terminology.
- 2. Team has several ideas for how to format questions asking for income amounts, including a couple grid formats. A usability MicroTest could be conducted on a small sample of people to help focus the question format before cognitive testing begins.



ASEC Applications

- To prepare for Round 2 Cognitive Testing
- Health Insurance
 - 8 interviews over 2 weeks
- Childcare
 - 5 interviews over 2 days (disrupted by return to office)
- Recruited both from sample of prior respondents
- Mini-report



How it Went

Very successful!

From the Health Insurance SME on the project:

"I liked MicroTesting because it gave us a chance to probe respondents while the questions being tested were still fresh in their minds. You can dive right in where it counts the most. And because it was a short instrument, focused on a few questions, respondents were very engaged. We made really important progress on our instrument using this method. I'm a fan of MicroTesting!"



Summary

- MicroTesting is a short qualitative test, designed to help researchers focus on subsets of the instrument and get results more quickly
- Allows for additional insights and tweaks during a lengthy questionnaire development project
- Functions like a larger cognitive test
- Meant to supplement, not replace, larger cognitive tests
- Seems to be a promising technique!

MicroTesting vs. Hallway testing

- Very similar
- Hallway testing can often be "emergency" testing
- MicroTesting is more deliberate
 - OMB approval, more than 9 cases across rounds
 - Intentional part of qualitative testing design
 - Recruitment quotas
