Col. 5. CITIZENSHIP OF THE PERSON: Naturalized, N; Foreign born, F; Alien, A.
Col. 6. MARIED PERSON AT WHAT AGE: Age at marriage.
Col. 7. DID THE PERSON SAY A JOB: Yes, Y; No, N.
Col. 8. DID THE PERSON SAY A JOB: Same as Col. 7.
Col. 9. DID THE PERSON SAY A JOB: Same as Col. 7.
Col. 10. DID THE PERSON SAY A JOB: Same as Col. 7.
