Item 17: SPECIAL CASES - Enter Yes also for persons who would have been looking for work, except for: (a) own temporary illness (b) indefinite or more than 30-day layoff (c) belief that no work was available. Item 28: CODES FOR GRADE ATTENDED. Item 34: To enumerators: If worked last year (1 or more weeks in item 30): Is there any entry in items 20a, 20b, and 20c? Item 35a: What kind of work did this person do in his last job? Item 35b: What kind of business or industry did he work in? Item 35c: Class of worker (P, G, O, or NP, as in item 20c). Item 36: If ever married (Mar, Wd, D, or Sep in item 12): Has this person been married more than once? Item 37: If Mar - How many years since this person was (last) married?
