## Summary

New orders for manufactured goods in October increased \$4.1 billion or 1.7 percent to \$244.0 billion, the Department of Commerce, Bureau of the Census reported today. This follows an increase of 1.3 percent in September and a 2.2 percent decrease in August. Excluding defense, new orders were up \$1.9 billion or 0.8 percent, the eighth increase this year. New orders without transportation equipment decreased \$1.2 billion or 0.6 percent.

Shipments decreased \$1.8 billion or 0.7 percent to \$244.0 billion, following a 2.0 percent increase in September and a 2.5 percent decrease in August. Excluding defense, shipments decreased \$1.2 billion or 0.5 percent. Without transportation equipment, shipments were down \$2.4 billion or 1.1 percent.

Unfilled orders were relatively unchanged at \$475.8 billion, the lowest level since December 1988. This follows thirteen consecutive monthly declines. Excluding defense, unfilled orders increased \$0.3 billion or 0.1 percent. Without transportation, unfilled orders increased \$0.1 billion.

Inventories decreased \$0.6 billion or 0.1 percent to \$383.8 billion, following a 0.3 percent decrease in September. Without defense, inventories decreased \$0.5 billion, following five monthly increases. The inventories-to-shipments ratio increased from 1.56 in September to 1.57 in October.

## New Orders

New orders for durable goods in October increased \$4.9 billion or 4.1 percent to \$124.7 billion. This increase, the largest since a 12.1 percent rise in July 1991, follows a 0.4 percent increase in September.

Transportation equipment had the largest increase, up \$5.3 billion or 19.7 percent to \$32.1 billion, primarily due to aircraft and parts and motor vehicles and parts. Primary metals increased \$0.4 billion or 4.2 percent to \$10.3 billion, with increases in all categories. Industrial machinery and equipment had the largest decrease, down \$0.4 billion or 1.9 percent to \$20.8 billion, primarily due to metalworking machinery and engines and turbines.

New orders for nondurable goods decreased \$0.8 billion or 0.7 percent to \$119.3 billion, following a 2.3 percent increase in September. This is the second decrease in the last three months. The largest decreases were in tobacco products, chemicals and allied products, and food and kindred products.

## Shipments

Shipments of durable goods in October decreased \$0.4 billion or 0.3 percent to \$124.9 billion. This follows a 1.6

percent increase in September. All major groups had decreases except transportation equipment, electronic and other electrical equipment, and stone, clay, and glass products. Instruments and related products had the largest decrease, down \$0.5 billion or 4.4 percent to \$10.1 billion, with decreases in all categories. Transportation equipment had the largest increase, up \$0.6 billion or 1.9 percent to \$32.2 billion, due to motor vehicles and parts.

Shipments of nondurable goods were down \$1.4 billion or 1.2 percent to \$119.1 billion, following a 2.4 percent increase in September. This is the second decrease in the last three months. The largest decline was in tobacco products, down \$1.1 billion. Chemicals and allied products and food and kindred products both declined \$0.4 billion.

## Unfilled Orders

Unfilled orders for durable goods in October decreased \$0.3 billion to \$452.9 billion, the lowest level since \$450.0 billion in December 1988. This is the fourteenth consecutive monthly decline. All major groups declined except fabricated metal products and electronic and other electrical equipment. The largest decrease was in primary metals, down \$0.4 billion or 2.1 percent to \$19.9 billion. Transportation equipment was down \$0.1 billion to \$249.1 billion, as decreases in shipbuilding and tanks and motor vehicles and parts more than offset increases in railroad equipment and aircraft and parts. Transportation equipment has declined in thirteen of the last fourteen months and is at the lowest level since \$245.6 billion in October 1989. Unfilled orders for nondurable goods increased \$0.2 billion or 1.1 percent to \$22.9 billion.

## Inventories

Inventories for durable goods in October decreased \$1.1 billion or 0.5 percent to \$239.4 billion, the twelfth decline in the last thirteen months. The largest decreases were in electronic and other electrical equipment and instruments and related products, both down \$0.3 billion.

Nondurable goods, up \$0.6 billion or 0.4 percent to \$144.4 billion, have increased for nine consecutive months. Chemicals and allied products had the largest increase, up \$0.3 billion. The largest decrease was in petroleum and coal products, down \$0.2 billion.

By stage of fabrication, finished goods decreased 0.8 percent in durables and increased 0.7 percent in nondurables. Work in process was up 0.4 percent in durables and down 0.1 percent in nondurables. Materials and supplies decreased 1.5 percent in durables and increased 0.2 percent in nondurables.




## Total Manufacturing

Inventories to Shipments



Three Month Moving Averages


Billions of Dollars
