## **Summary**

New orders for manufactured goods in January increased \$5.2 billion or 1.6 percent to \$325.8 billion, the Department of Commerce, Bureau of the Census reported today. This follows a 0.7 percent December increase. New orders for January 2002 were 3.4 percent below January 2001.

Shipments increased \$6.5 billion or 2.0 percent to \$333.2 billion, following a 0.6 percent December increase. Shipments for January 2002 were 4.1 percent below January 2001.

Unfilled orders, down twelve of the last thirteen months, decreased \$7.4 billion or 1.4 percent to \$536.4 billion, following a 1.1 percent December decrease. The unfilled orders-to-shipments ratio was 4.08, down from 4.24 in December.

Inventories, down twelve consecutive months, decreased \$2.8 billion or 0.6 percent to \$444.4 billion, following a 0.9 percent December decrease. The inventories-to-shipments ratio was 1.33, down from 1.37 in December.

## **New Orders**

New Orders for manufactured durable goods in January increased \$3.5 billion or 2.0 percent to \$178.0 billion, revised from the previously published 2.6 percent increase.

Transportation equipment, led by motor vehicles and parts, had the largest increase, \$2.0 billion or 4.1 percent to \$51.0 billion. Computers and electronic products, up four consecutive months, increased \$0.6 billion or 1.9 percent to \$34.0 billion, due to semiconductors.

New orders for nondurable goods increased \$1.7 billion or 1.1 percent to \$147.8 billion, led by an increase in food products.

## **Shipments**

Shipments of durable goods in January increased \$4.8 billion or 2.6 percent to \$185.5 billion, revised from the previously published 2.9 percent increase.

Transportation equipment, up four consecutive months, had the largest increase, \$1.5 billion or 2.7 percent to \$55.7 billion, due to motor vehicles and parts. With the largest increase on record, machinery increased \$1.3 billion or 5.8 percent to \$23.6 billion,

mostly due to turbines, generators, and other power transmission equipment. Computers and electronic products, up four consecutive months, increased \$0.7 billion or 1.9 percent to \$34.7 billion, due to semiconductors. Primary metals increased \$0.6 billion or 5.1 percent to \$11.5 billion; this was the largest increase since December 1994.

Shipments of nondurable goods increased \$1.7 billion or 1.1 percent to \$147.8 billion. Food products had the largest increase.

## **Unfilled Orders**

Unfilled Orders for durable goods in January, down twelve of the last thirteen months, decreased \$7.4 billion or 1.4 percent to \$536.4 billion, revised from the previously published 1.3 percent decrease.

Transportation equipment, down seven of the last eight months, had the largest decrease, \$4.7 billion or 1.7 percent to \$272.0 billion. Machinery, down six of the last seven months, decreased \$0.8 billion or 1.4 percent to \$57.2 billion. Computers and electronic products, down fourteen consecutive months, decreased \$0.7 billion or 0.6 percent to \$124.4 billion.

## **Inventories**

Inventories of durable goods in January, down twelve consecutive months, decreased \$1.7 billion or 0.6 percent to \$281.0 billion, unrevised from the previously published 0.6 percent decrease. Durable goods inventories were at their lowest level since November 1997.

Transportation equipment, down seven of the last nine months, had the largest decrease, \$0.6 billion or 0.7 percent to \$73.5 billion. Primary metals decreased \$0.4 billion or 1.8 percent to 19.4 billion. Machinery, down ten consecutive months, decreased \$0.3 billion or 0.7 percent to \$48.2 billion.

Inventories of nondurable goods, down twelve consecutive months, decreased \$1.1 billion or 0.7 percent to \$163.5 billion.

By stage of fabrication, January finished goods decreased 1.3 percent in durables and 1.2 percent in nondurables. Work in process increased 0.2 percent in durables and 0.9 percent in nondurables. Materials and supplies decreased 0.8 percent in durables and 0.6 percent in nondurables.






**Total Manufacturing**

Moving Average




**Total Manufacturing**

Moving Average




**Total Manufacturing**

Inventories to Shipments




**Nondefense Capital Goods**

Moving Average




**Nondefense Capital Goods**
